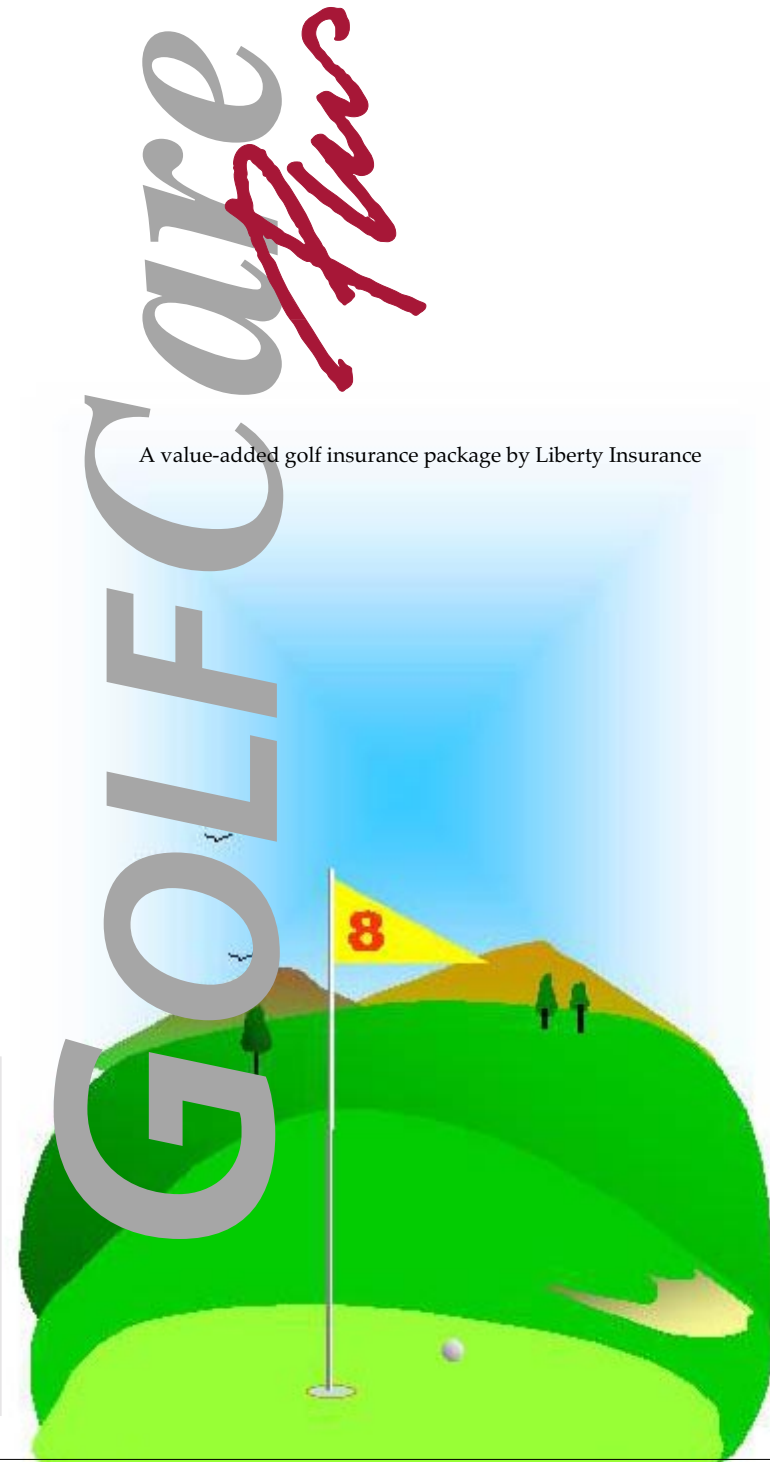
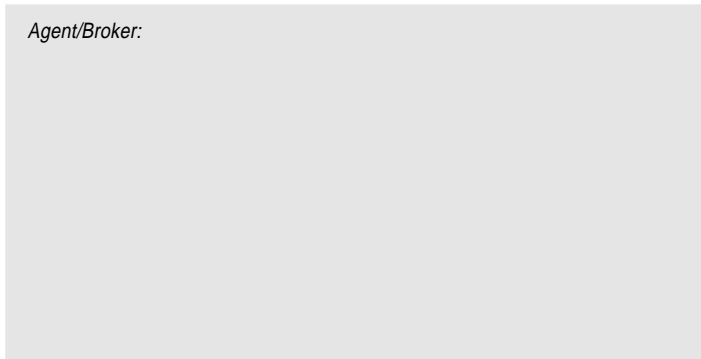

GOLFCare Plus

Section & Coverage

1. PERSONAL LIABILITY

Insures against third party claims for bodily injury or property damage caused by your negligence whilst playing or practising golf. Cover includes legal costs and expenses incurred with our written consent. Territorial limit is Worldwide

2. PERSONAL ACCIDENT

Compensates for death or disablement following accidental bodily injury whilst playing or practising golf. The compensation is doubled if death is as a result of a lightning strike at the Golf Course.

3. MEDICAL EXPENSES

Pays for medical and hospital expenses incurred as a result of accidents whilst golfing.

4. GOLF EQUIPMENT & PERSONAL EFFECTS

Covers loss or damage to golfing equipment and personal belongings caused by fire, burglary, housebreaking or theft whilst in any recognised golf club premises. An excess of S\$50 will apply to each claim.

5. GOLF CLUBS

Pays for accidental breakage of golf clubs occurring during the course of actual play or practice. An excess of S\$50 will apply to each claim.

6. HOLE-IN-ONE

Reimburses the sum insured plus the expenses incurred at the golf club premises following the scoring of a hole-in-one.

7. EMERGENCY MEDICAL EVACUATION & REPATRIATION
